The terms and conditions below are used to regulate services provided by Modular Economy regarding the use of <https://modular-economy.id/> and all of its products or services. You as a user are advised to read thoroughly all of the terms & conditions below, since it can affect your rights & obligations under law.

By using <https://modular-economy.id/> user is deemed to have read, understood and agreed to all that is written within the content in these Terms & Conditions, as a form of a valid agreement between you and Modular Economy. If you do not agree with one part or all of the content of the Terms and Conditions then you are not allowed to use our services.

A. DEFINITIONS

1. **Modular Economy** is the sole owner who runs a web-based development services business with the site address at <https://modular-economy.id/>, which is an online platform, where your website can be built by yourself or by the development team.
2. **The official website for Modular Economy** is <https://modular-economy.id/>
3. **Terms & Conditions** are a form of agreement between you and the Modular Economy which contains a set of policies that govern the rights, obligations and responsibilities of Modular Economy with you, and also contains guidelines for using this system.
4. Customers are registered users who have joined a subscription package, and request to create a website / services from products provided by Modular Economy.
5. **The official Modular Economy** account number is a bank account that has been agreed by Modular Economy team for the transaction process for making website services. The Modular Economy Account is a savings account :
 - BCA(0860267179) a/c of Hendri Tanadi (Indonesia)
 - POSB (244-37775-0) a/c Hendri Tanadi (Singapore).
 - Virtual Account given to each agent
 - BCA QRIS from the account said above

B. INSTANT WEB

1. By continuing, you as a user agreed that you are someone who understands the contents of this agreement in full awareness, without coercion, and is able to follow what is determined and lawfully submit to its regulation.
2. Users who have started a **product subscription** from Modular Economy have the right to request an **OTP** from the agent to access the edit function and customers will be given **1 week to try (free trial)**. After the free trial period is completed, the subscription package will start for the agreed period (paid). If the subscription period has expired, the customer must extend the subscription time by contacting the agent and making a payment transaction no later than a week before due date.
3. Registered users can **access site** and can choose a design from a set of templates provided.
4. Users can **edit their own instant website** (there is no editing limit, but they are required to request an OTP from the registered agent), or can be assisted by the agent for one time editing. After the site is published, editing by the agent is subject to IDR 100,000 / page / edit.
5. Users can choose **packages** according to their needs. If an additional page is required, the user can contact the registered agent.
6. Users can fill in **content** according to user needs. **It is strictly forbidden to** publish pornographic content, fraud, hoaxes or anything that is immoral and violates applicable rules / norms.
7. User accounts that violate content regulations will be immediately **blocked**, users will be given email notifications about blocking via the email address registered during the subscription.
8. Modular Economy has the right to **display website designs** and domain names on our portfolio page or at the bottom of our client list page, except for exclusive website designs that have prior approval not to be displayed.

9. In long term effort to secure the website, both client and Modular Economy have a shared responsibility. We will try to secure it from the server side and clients are required to keep it safe by:
 - a. Not using predictable passwords.
 - b. Don't give account access to people you don't trust.

C. CONTENT

1. Instant website content that has been created may not contain racism (regarding religion, race, skin color, etc.), pornography, photos and / or words which offend the law in any way, also abide with copyright and intellectual laws.
2. Users are fully responsible for the content created under their site.
3. Users are prohibited from using images that contain watermarks / photos that indicate someone else's proprietary artwork.
4. When uploading or posting, you are implicitly giving consent to non-exclusive, perpetual, irrevocable, royalty-free rights, sub-license rights to exercise any and all copyrights, trademark publicity, database rights and intellectual property rights has been owned by the user in all content, in any media known now or in the future. After that, everything is approved by applicable law, the user puts aside the moral law and promises not to claim all rights in any way to the Modular Economy.
5. The user guarantees that when uploading content to the site that is owned, the user does not violate any intellectual property laws. Users will be personally responsible if there is content that violates intellectual property laws when uploading content.
